The Ministry of Municipalities and Public Works (MMPW) has applied for financing' from International Development Association (ID.A) toward the cost of the Second Emergency Water Supply and Sanitation Project, and it intends to apply part of the proceeds toward payments under the contract for assembling testing and commissioning of a Water Treatment Plant having a net output of 1,000 m3/hr of drinking water, complete of services and ancillary items and replacement of pipelines is about 14.75 km length.

The Ministry of Municipalities and Public Works intends to pre-qualify contractors and / or firms for Construction of Works comprising: (1) a raw water intake, (2) WTP with capacity of 1,000 cubic meters per hour, (3) pumping station, (4) treated storage tank, (5) treated water transitions pipeline, and (6) replacement of about 15 km of pipes of various diameters in the water distribution network and house connections.

The applicant shall have strong and proven records in construction and capable of demonstrating sufficient technical, financial and marginal capabilities to undertake the execution of the contract. The applicant shall also have an annual value of construction work not less than US\$20,000,000 and shall have completed one or more projects in similar complexity and of value not less than US\$ 15,000,000 over the last 5 years. It is expected that invitations to bid for prequalified applicants will be issued in April 2008. Prequalification will be conducted through prequalification proce-

dures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004. and is open to all bidders from eligible source countries, as defined in the guide-lines.

Interested eligible applicants may obtain further information, and inspect the prequalification documents, from the Ministry of Municipalities and Public Works at the address below. A complete set of prequalification documents in English may be purchased by interested applicants on the submission of a written application to the address below and upon payment of a non-refundable fee of US\$ 100.
